A RESOLUTION OF THE DEVELOPMENT REVIEW COMMITTEE OF ALACHUA COUNTY, FLORIDA, ESTABLISHING THE COMMITTEE'S RULES OF PROCEDURE; PROVIDING FOR RESOLUTION OF CONFLICTS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Alachua County Development Review Committee was established by the Alachua County Board of County Commissioners through the adoption of the Section 401.12 of the Unified Land Development Code for review and consideration of development applications in Alachua County; and

WHEREAS, the Alachua County Development Review Committee (Committee) is charged with the responsibility of adopting rules of procedure necessary to its governance and the conduct of its affairs in keeping with applicable provisions of Florida Law and ordinances of Alachua County, as provided in Section 401.16 of the Unified Land Development Code; and

WHEREAS, the Committee's rules of procedure provide guidelines for the conduct of its meetings;

NOW, THEREFORE, BE IT RESOLVED BY THE DEVELOPMENT REVIEW COMMITTEE OF ALACHUA COUNTY, FLORIDA:

Section 1. That Exhibit A, titled, *Alachua County Development Review Committee Rules of Procedure*, shall constitute the rules of procedure that govern the Committee's transaction of public business.

Section 2. That any resolution in conflict with the rules of procedure established by this resolution is hereby repealed.

Section 3. That this resolution shall take effect immediately upon its adoption.
